Kamiyama Artist-in-Residence Program 2026 Application Guidelines

[1] PHILOSOPHY

Creating "Kamiyama International Cultural Village" is the main purpose behind the KAIR Project. Our hope is that the artists will produce works full of originality, influenced by the experience of spending time amidst the timeless nature of Kamiyama, deep in the Japanese countryside, and inspiration from interacting with the friendly local people. Through the works created by the artists as they come into contact with the tangible and intangible 'God's Mountain' (the meaning of 'Kamiyama'), we hope to be able to discover what impact 'encounters with the unknown' has upon the artists and the community itself.

Main organizer: Kamiyama Artist in Residence Committee (KAIR)

[3] PERIOD OF PROGRAM

3 September – 11 November, 2026

[4] NUMBER OF INVITATION ARTISTS

2 to 3 artists

[5] APPLICATION REQUIREMENTS

To apply for the program, applicants must meet all of the following requirements:

- a) Be involved with painting, drawing, sculpture, installation, land art and other art making. Grants are not made in the disciplines of production art.
- b) Be capable of working independently and managing daily life on one's own.
- c) Be able to produce at least one artwork during the residency period and take responsibility for the presentation of the work, including its display and removal.
- d) Understand the purpose of one's visit to KAIR and be able to present over 4/5 of period of the program.
- e) Be able to lead community life with other artists on the program and to communicate with local people including the exchange program.

- f) Be able to speak and understand English daily conversation.
- g) Be in good health.
- h) Commit to a minimum stay of 40 days prior to the exhibition.
The official residency period is from 3 September to 11 November (69 days). Participation for a shorter duration may be accepted. The Artist must clearly indicate their intended dates of stay on the application form. In such cases, the living allowance will be reduced proportionally.
- i) Acknowledge that KAIR operates with limited financial and material resources and cannot provide the same level of facilities or support as art museums or galleries. The Artist must be prepared to work within these constraints, make effective use of available resources and materials, and take full responsibility for time management and completion of the final presentation.
- j) Clearly indicate on the application form whether professional assistance from a third party is required for any aspect of the proposed work.

[6] HOW TO APPLY

Applicants must submit all required documents to **apply.kair@gmail.com by 23:59:59 JST(UTC+9) on 27 February, 2026.**

Applicants are required to submit the necessary documents in Japanese or English. Please refer to the “Application procedure” (page 5 to 7) for the required documents.

[7] SCREENING AND NOTIFICATION

The selection committee of KAIR will strictly screen all applicants.

The result of selected artists will be announced on our website **by 15 May, 2026.**

[9] OBLIGATIONS ON KAIR AND ARTIST

Upon carrying this program out, the KAIR and the Artist have a following obligation to each other.

Subject	Nature of Obligation
VISITING KAMIYAMA	
Airfare	<p>The KAIR will pay the following travel expenses for participating artists:</p> <p>[OVERSEAS RESIDENT] A one-time round-trip economy class airfare between the airport nearest to the Artist's home and Osaka Kansai International Airport (KIX) (payable up to 200,000JPY). Transportation by limousine bus from KIX to Tokushima station is included. Ground transportation from Tokushima station to Kamiyama will be arranged by the KAIR.</p> <p>[DOMESTIC RESIDENT] A one-time round-trip economy class airfare, railway or bus fare to Tokushima (payable up to 75,000JPY). Ground transportation from Tokushima airport or Tokushima station to Kamiyama will be arranged by the KAIR.</p> <p>* Please note that the Artist is responsible for any transportation costs for goods or materials.</p>
Visa	The Artist must make arrangements for a visa with which they may enter Japan, if necessary. Please enquire at the Japanese Embassy in your country.
WORKING, EXHIBITION (PRESENTATION) AND THE EXCHANGE PROGRAM	
Activities	The Artist must participate in the presentation and in the exchange program during the residency period.
Material allowance	The KAIR will provide actual expenses as material allowance up to 250,000JPY (requires receipts). If it exceeds this limit, the Artist must pay the difference.
Studio	<p>Studio spaces are available within the town, including a former preschool building, a former theater building, and other facilities as agreed upon through consultation. Room assignments will be determined through consultation among the artists.</p> <p>The Artist is required to keep the studio clean and to return it to its original condition upon departure from Kamiyama. In the event that the Artist causes damage, whether intentionally or through negligence, the Artist shall be responsible for compensating for such damage.</p>
Exhibition	<p>Each exhibition venue will be determined in consultation between the KAIR coordinator and the artist.</p> <p>It is essential that the Artist be able to exhibit their work independently. The Artist is responsible for the installation, maintenance, and care of their own work during the exhibition.</p> <p>The KAIR will provide materials for the presentation (e.g., panels, captions) for the audience, upon discussion with the Artist.</p>
Exchange Program	<p>The Artist must participate in the following exchange activities:</p> <ul style="list-style-type: none"> -Welcome party and Artist's talk -International food exchange -Open Studio -Art Tour (scheduled on the first day of the exhibition) -Lecture or Workshop at schools (either or both may be scheduled) <p>The KAIR will provide materials necessary for the exchange program.</p>
ABOUT LIVING IN KAMIYAMA	
Living Allowance	<p>The KAIR will provide the living cost of 200,000JPY during the period of stay for the Artist. However, in case of late arrival and advanced departure, the living allowance will be reduced in proportion.</p> <p>The KAIR will pay living costs such as electricity, gas, water, etc. and also provide necessary daily housekeeping items.</p>

Accommodation	<p>The KAIR will provide one of ferroconcrete two-stories row house approximately 60m² (650ft²) with a kitchen, a shower, a toilet, and three straw-matted(tatami) rooms. A meal is self-cooking.</p> <p>The Artist must keep their house clean and return it to its original condition when the Artist leaves Kamiyama. If the Artist causes damage, whether intentionally or due to negligence, the Artist will be required to compensate for the damage.</p>
Guests	<p>If the Artist wish to be accompanied by a spouse, partner, assistant or child, the Artist must consult with the committee at the time of application to the program. An additional fee will be charged.</p> <p>If the Artist's guest causes damage, whether intentionally or due to negligence, the artist will be responsible for compensating the damage.</p> <p>Guests are not permitted to stay at the Artist's apartment without prior approval from the committee. We can provide the Artist with a list of accommodation options in town for guests.</p>
Transportation	<p>The KAIR will provide the Artist with a shared automobile, motor scooter, or bicycle for local use within the town during their stay. If the Artist causes damage, whether intentionally or due to negligence, the Artist will be required to compensate for the damage.</p> <p>The KAIR will cover fuel costs for travel within Kamiyama town, except for personal use outside the town. The shared car may only be used within Tokushima Prefecture. For travel beyond the prefecture, the Artist must arrange and contract a rental car independently.</p>
Communication	<p>The KAIR will provide a SIM card for the Artist to use in their mobile phone.</p> <p>Both the apartment and the studio are equipped with high-speed internet access.</p>
Insurance	<p>The Artist should be covered by one's own travel insurance (for injury and sickness) for the duration of residence. The KAIR will not to be guaranteed with insurance for the Artist.</p>
OTHER	
Cooperation with Record of Activities	<p>The KAIR will photograph works and produce video recordings of all activities during the residency period. The Artist is required to cooperate with these documentation efforts.</p>
About Artists' Record Book	<p>KAIR will create a record book of the Artist's activities and works.</p>
About Artist's report	<p>The Artist must submit a report about one's experience during the KAIR. This report will include thoughts and opinions about all aspects of the residency.</p>
Cooperation with Public Relations	<p>The Artist should cooperate with public relations activities (e.g., press conferences or other requests), where feasible. However, it is possible to refuse when there is fear of an invasion of the Artist's privacy and interference with the Artist's work.</p>
Assistance for Activities	<p>The KAIR has facilitators and volunteers who support the Artist during the residency. The scope and contents of this support will be discussed with the Artist, facilitators, volunteers, and the KAIR committee during the guidance period.</p>

[10] OWNERSHIP AND COPYRIGHT

The work produced by the Artist during one's stay will become the property of the KAIR.

Exceptions might apply, depending on prior discussion.

The Artist reserves a copyright of one's works. The KAIR reserves the right to record (photo, film, etc.) and use them for publicity. And anyone who is permitted by the KAIR may use the record freely.

[1] INTRODUCTION

Program details and conditions are explained on pages 1–4.

Please read them carefully before completing the application form and submitting your application.

[2] HOW TO APPLY

Please submit the following documents by **23:59:59 JST(UTC+9) 27 February, 2026** for your application. Submission by email is recommended.

a) **APPLICATION FORM:** The application form should be completed and submitted with the other required application materials.

Please outline your work plan for KAIR on Page 2 of the application form (Work Proposal), including materials, size, and other relevant details. Your plan may be adjusted after arrival in Kamiyama, subject to discussion with a committee member. At the time of application, you must submit at least one work plan.

If you require the professional expertise of a third party to assist with any aspect of your work, you must indicate this in your work proposal.

An attachment of drawings, sketch, or image of proposed work is required. Please clarify the document name (ex: work proposal) upon submitting application materials.

b) IMAGES and INFORMATION SHEET:

- Submit no more than 8 images of recent works as an attachment to their application.

Each image must be in JPEG format and smaller than 1 MB.

* You may use a file transferring service to submit your documents.

- Provide an Image Information Text Sheet that lists all images by number.

* Ensure that the file names of the images match the numbering on the information sheet.

The sheet should include the following details for work:

- Title of work
- Date of completion
- Medium
- Size
- Work description (Optional)

- For performance or video works, provide a URL to the video (e.g., YouTube, Vimeo).

Include an information sheet listing the URLs of your works.

*CD-R (JPEG), DVD, or video may be submitted by post as a substitute for images. DVDs must be edited to within 5 minutes.

*CD-Rs, DVDs, videos, and other supporting materials sent by post will not be returned.

c) CV (Curriculum Vitae)

※Copies of reviews and other material should be limited to no more than 10 pages.

d) FEE: The application fee of **8,000 JPY should be in the form of;**

References: Do not submit letters of recommendation. References listed on the application form will be contacted if necessary.
